**A RESOLUTION AUTHORIZING THE VILLAGE OF WEBBERVILLE TO ENTER
INTO A CONTRACT WITH THE MICHIGAN DEPARTMENT OF
TRANSPORTATION TO IMPLEMENT THE TRANSPORTATION ALTERNATIVE
PROGRAM**

WHEREAS, The Michigan Department of Transportation hereinafter referred to as MDOT; has submitted contract number 15 – 5445 to the Village of Webberville, a Michigan municipal corporation, hereinafter referred to as the VILLAGE; for the purpose of fixing the rights and obligations of the parties agreeing to the following improvements; hereinafter referred to as the PROJECT, in the VILLAGE and estimated in detail on EXHIBIT “I”, dated July 28, 2015, attached hereto and made a part hereof:

PART 1 – FEDERAL PARTICIPATION

Bicycle and pedestrian safety improvement work for the Webberville Elementary School, Webberville Middle School, and Webberville High School; including concrete sidewalks and crosswalk installation work; and all together with necessary related work; for the following locations:

Both sides of Grand River Avenue from Elm Road to Summit Street
Both sides of Cherry Street from Howard Street to Main Street
Both sides of Grand River Avenue from Maple Street to Gramer Road
Both sides of Maple Street from Monroe Street to Grand River Avenue
Both sides of Franklin Street from Oak Street to Grand River Avenue
Both sides of Pardee Road east and west of Main Street
Both sides of Chestnut Street from Clark Street to Maple Street
Both sides of Beech Street from Howard Street to Main Street
Both sides of Pine Street from Howard Street to Main Street
Both sides of Walnut Street from Summit Street to Franklin Street
Both sides of Clark Street from Oak Street to Walnut Street

PART 2 – STANDARD AGREEMENT PROVISIONS

WHEREAS, pursuant to Federal law, monies have been provided for the performance of transportation enhancement activities, and

WHEREAS, it has been determined that the PROJECT qualifies for such funding by virtue of its direct relationship with the international transportation system; and

WHEREAS, the reference "FHWA" in PART I and PART II refers to the United States Department of Transportation, Federal Highway Administration; and

WHEREAS, the PROJECT, or portions of the PROJECT, at the request of the VILLAGE, is being programmed with the FHWA, for implementation with the use of Federal Funds under the following Federal program(s) or funding:

TRANSPORTATION ALTERNATIVE PROGRAM

WHEREAS, the VILLAGE has assigned Brad Hitchcock, Sr. , President of the VILLAGE, and Michael Killackey, Department of Public Works Supervisor, as the authorized signers for the contract between MDOT and the VILLAGE.

WHEREAS, the parties hereto have reached an understanding with each other regarding the performance of the PROJECT work and desire to set forth this understanding in the form of a written contract;

NOW, THEREFORE, in consideration of the premises and of the mutual undertaking of the parties and in conformity with applicable law the Village will enter into the contract prepared by MDOT and submitted on September 8, 2015.


